

**PARENT PARTNERSHIP AGREEMENT**

1. I have read, understand and agree to the following standards:
  1. Faith Academy Bellville's (FAB) Philosophy and Statement of Faith and agree my child will be taught according to scriptural principles.
  2. I have a responsibility before God to be actively involved in the education and discipline of my child.
  3. I agree to uphold and support the high academic standards of the school by providing a peaceful place at home for my child to study and to give my child encouragement in the completion of homework assignments.
  
2. I accept the challenge to:
  1. "Train up a child in the way he should go" Proverbs 22:6
  2. Pledge that this training will be carried on in the home and place my trust in FAB to extend that training.
  3. Teach my child honesty by example and abide by the school's policy of: "Students with a temperature of 100 degrees or above will not be allowed to remain in class. A child may return to class when he or she has been without fever for 24 hours unaided by any fever-reducing medication.
  4. Have my student(s) attend all classes at least 90% of the time. This equates to only 9 absences per semester (18 total for the school year). FAB does not consider absences as excused or unexcused, but honors the parents' determination of keeping the student at home. However, administration (possibly board) approval is required for credit to be given in classes with more than 18 absences.
  
3. I will faithfully partner with the school by:
  1. Prayers and a positive attitude
  2. Committing to a good report by sharing any complaints and negative comments only with the people involved according to Matthew 18:15 using FAB's chain of command.
  3. Abiding by the Policies and Procedures of the school as found in the Policy Manual available at FAB.
  4. Participating in the following:
    1. Attend the Parent Kick-Off Night (orientation)
    2. Attend *Parenting with Love and Logic* six week series. The series will be offered once in the fall and once in the spring. Details are on FAB calendar.
    3. Donate time and/or resources (approximately 4 hours) to support FAB's two important fund raisers. Volunteer opportunities abound and will be available in the months leading up to the event, as well as the many hours needed on the day of the event. If absolutely necessary, parents may opt for a buyout agreement (see fundraising director for details)
    4. Observe my child(ren) in the classroom for one hour each semester signing in at the front office and following all policies.
    5. Attend one parent/teacher conference for each of my children for the first and third report card (October and March).

## 4. I agree to:

1. Attend academic and/or disciplinary conferences as needed at the request of parents, teachers or administration.
2. Follow all dress code policies in regard to my child(ren) as they are listed in the policy manual for both on-campus and off-campus FAB activities.
3. Follow and support all laws regarding:
  1. Under-age consumption and/or possession of alcohol, tobacco or any illegal substance
  2. Under-age possession of fire arms (as per Texas law).

## 5. I will fulfill my financial commitment to pay for all listed below as posted in the financial section of my FACTS account.

1. Textbook Fee for Nursery through twelfth grade by July 1
2. Annual tuition as published and billed to me either in one payment\* OR in ten (10) monthly payments. Students will not be admitted to class if textbook fee and the first month's tuition is not paid. A \$50 LATE FEE will be charged per student for tuition not paid by the 5th of the month.
3. FALCON fee (if applicable) as published and billed
4. STAY and PLAY FEE as published and billed
5. All Athletic, field trip, and other fees assessed
6. Lunch balances
7. Night of Knights Partnership Fee of \$35 per student as billed
8. Original 10 Night of Knights' Raffle Tickets per student not sold by my student(s)

## 6. I pledge that if, for any reason, my child does not respond favorably to the FAB:

1. To do everything in my power to cooperate with FAB to help my child make the necessary adjustments
2. Within a 9 week probationary period to amicably withdraw my child
3. Upon withdrawal to fill out an exit form and have an exit interview to enable FAB to continually improve.

## 7. I understand that FAB will withhold records for failure to pay tuition/account balances. Students with any outstanding balance shall not graduate nor be promoted to the next grade. Should I incur financial difficulties, I will give FAB an opportunity to work with me and abide by the board's decision.

8. I understand that my child(ren) must have medical insurance coverage during school activities. I will provide proof of current coverage. If I do not have insurance, I may contact [www.texaskidsfirst.com](http://www.texaskidsfirst.com) to purchase required coverage. FAB will not be held responsible for my family's accident or health matters. I will update my insurance information in my FACTS Family Portal.

9. In keeping with 1 Corinthians 6:1, I agree that if I or any member of my immediate family reach a point of disagreement on an issue of non-criminal nature with FAB and/or its corporate legal entity, rather than taking the dispute to a civil court, I will submit to a board of conciliation. The members of the board of conciliation will be selected by myself and officials of FAB. I agree that the procedure to be followed, including costs involved, will be that which has been established by the Christian Legal Society.

10. I, as parent/guardian of the student applicant, do sincerely give my pledge to the above items for as long as my child(ren) are enrolled at FAB. I understand that failure of the parents or child to comply with the established FAB Policies and Procedures and this Parent Partnership Agreement may forfeit my child(ren)'s privilege to attend FAB. **RECORDS OF PARTICIPATION AND SUPPORT WILL BE MAINTAINED BY OFFICE PERSONNEL.** Failure to uphold any of these requirements will be addressed by an administrator.
